## Information on processing personal data of the client - natural person, including entrepreneurs

- 2. Personal data shall be provided to make and perform the Agreement between you and DELTA BOX.
- **3.** Your personal data may be processed for the following purposes:
  - a) performing the Agreement or taking actions upon your request before making the Agreement (under Article 6(1)(b) of Regulation (EU) No 2016/679 of the European Parliament and of the Council of 27 April 2016 General Data protection Regulation, "GDPR");
  - b) fulfilling DELTA BOX legal obligations concerning the performance of the Agreement, in particular those relating to accounting and tax settlements, handling of complaints (under Article 6(1)(c) of the GDPR);
  - c) determining, seeking or defending any claims between you and DELTA BOX, which constitutes a legitimate interest of DELTA BOX under Article 6(1)(f) of the GDPR;
  - d) providing services at DELTA BOX to ensure the security of DELTA BOX and its employees, which constitutes a legitimate interest of DELTA BOX under Article 6(1)(f) of the GDPR;
